Revisions for Appendix 75-A, a Reality

Appendix 75-A has been in the revision status for some time now, but the proposed revisions have been posted on the New York State Register, February 4, 2009. The documents can be accessed at http://www.dos.state.ny.us/info/register.htm. Comments will be received for 45 days from publishing date.



The major revisions in 75-A include:

1. A new category of onsite wastewater treatment systems

Enhanced

Treatment Units (ETUs). This category allows for a 33% reduction in absorption trench length and a 33% smaller basal area for areas with an RME.

- 2. Recognize that certain gravelless absorption system products allow increased infiltration surface area and therefore can be allowed a 25% reduction in absorption trench length.
- 3. All properly manufactured waste tire chips to replace stone in absorption trenches.
 - 4. Revise the daily flow rates.
- 5. Delete the Evaporation-Transpiration system.

- 6. Rescind the New Product/System Section.
- 7. Recognize part 75.6 in part 75 of existing Department regulations.
