

# RECAP OF PERMIT PROCESS CHANGE

At the June KWIC meeting the manager was asked to email the watershed inspectors and review the changes to them. This was done and the responses brought to the July KWIC meeting.

At the July KWIC meeting it was stated to the manager that there was a misunderstanding and the manager was asked to present the changes in protocol to the watershed inspectors and explain the changes.

In August it was difficult to get the watershed inspectors together due to vacations and after reviewing more of the content that needed changing there

appeared to be more problems. The manager prepared a letter to the directors and emailed the communication prior to the August meeting.

At the August meeting the communication and its discussion was postponed to the September meeting.

At the September 28 KWIC meeting the manager was asked to define and articulate the changes in the many forms and materials used as well as sending some referenced documents. On September 30 at the watershed inspectors meeting each inspector was assigned the task of

researching each of their municipalities for materials and documents that would need to be changed because there is not enough time to accomplish this work with one employee in the time provided. To date we have had no response from the watershed inspectors. The reference documents were sent to the directors and asked if they needed more.

### Software Project Update

Colby Petersen, Scott Demmin and the manager met on October 23 for 4.5 hours reviewing the tables and structuring of the program to eliminate duplication in the program. We each have some work to get done for the next step. This preparation work is essential for a quality product.
